**DRIVING SAFETY COURSE (DSC) REPLY FORM**

**Please submit the following by email, mail, or in person:**

1. Signed and notarized DSC Affidavit.
2. Court costs in the amount of \$144.00 or \$169.00 (if the violation occurred in a school zone). **NO PERSONAL CHECKS.** You can call and pay with a debit/credit card after you email the form. (5% processing fee applies.)
3. Copy of your valid Texas driver's license.
4. Proof of valid financial responsibility ( auto insurance card with you listed as a driver) emailed or faxed from your insurance company directly to the court.

**Once approved you will be required to:**

1. Present a certified copy of your driver's license record from the Texas Department of Public Safety within 90 days: (ORDER online at <https://txapps.texas.gov/tolapp/txldrctr/TXDPSLicenseeManager> (Version 3A)
2. Present your signed driving safety course completion certificate from a Texas Department of Licensing and Regulation approved course within 90 days from the date of your request.

If you fail to present to this court proof of completion of the driving safety course and a certified copy of your driving record, the court will require your appearance at a Show Cause hearing. If you fail to appear at the Show Cause hearing, the court will enter a conviction against you for the offense and impose a fine which will be due immediately.
